Official Minutes for the Regular Meeting of the Fire District

- Truck Maintenance Berg talked with Complete Auto Diagnostics and Repair as they have more to offer in taking care of high risk vehicles. They do more inspection points to the vehicles. They have ASE Certified Mechanic that would be doing the work. All oil changes would include the trucks taken into their diagnostic area and alignment rack. \$119.94 per vehicle for oil change and inspection and if have to do other work that would be additional. Their inspection form is far more complete and more items they look at than what the ASE inspection form has on the internet. They will provide a complete report on everything. Tom Sundeen will service the boat. ATV will be serviced at the Moose Lake Implement.
