**Agenda:** A motion was made by Nelson, seconded by Lower, to approve the Agenda. The motion passed unanimously.

**Minutes:** A motion was made by Lower, seconded by Lund, to approve the August minutes. The motion passed unanimously.

**Treasurer's Report:** Nelson reviewed the Treasurer's Report and Check Register. A Motion was made by Lower and seconded by Kirk to approve the Treasurer's Report and Check Register. The motion passed unanimously.

### **Department Report:**

 Chief – J. Hibke reported that on page 4 of the PERA of MN Statewide Volunteer Firefighter Plan, the 2025 benefit level is currently listed at \$3,200. J. Hibke recommended increasing the benefit level to \$4,000, noting that the fund would remain over 100% vested even with the increase. A motion was made by Nelson and seconded by Lund to raise the benefit level to \$4,000. The motion passed unanimously.

- J. Hibke reported 447 had lights issues, but they have been fixed.
- Assistant Chief: C. Hibke will reach out to the contact person of new truck.
- Captain Chambers reported last month's training went well in the Soo Pitts. Trainings this
  month will include livestock emergencies at the Barnum Fair Grounds. Other departments have
  been invited to this training. Cromwell FD is having a heavy vehicle extrication class and invited
  MLFD. On 9/11 we will bring a truck to Mahtowa Church who is doing a 9/11 service.
- First Lieutenant: No report.
- Second Lieutenant Trenhaile reported on the grant. Trenhaile said a compressor is approximately \$45,000, bottles are \$1,200 - \$1,400 each and should purchase 5 more for next year. Nelson said when they work on the truck loan they will include funds for the compressor. Nelson would also like a list of what is needed for the new truck for next month's meeting.
- Secretary J. Hibke read run report for Michalski.
- Relief Association: Davidson reported the golf tournament is this week and fundraising is going well.
